In particular, no warranty or representation whatsoever is given as to the condition, state, quality and fitness of any of the Furniture and Chattels and as to whether any of the Furniture and Chattels is or will be in working condition. The Furniture and Chattels will be delivered to the Purchaser upon completion of the sale and purchase of the residential property in such condition as at completion together with the residential property. In any event, no objection or requisitions whatsoever shall be raised by the Purchaser in respect of the Furniture and Chattels. For the avoidance of doubt, the First 3 Years Warranty Offer as set out in paragraph (4)(B2)(iii)8 does not apply to the Furniture and Chattels. This offer is subject to other terms and conditions.

Who is liable to pay the solicitors' fees and stamp duty in connection with the sale and purchase of a specified residential property in the Phase
