Section (II) - Submission of Registration of Intent for Session A and Session B before the First Day of Sale

2. Registrants must follow the procedures below.
3. A registrant (if the registrant is a corporation, then **all of its directors**) must **personally** (or (subject to the approval of the Vendor in its absolute discretion on a case by case basis) by his/her/their/its agent) submit the following:-
  - (a) not more than **four (4)** Registrations of Intent duly completed and signed by the registrant;
  - (b) each Registration of Intent shall be accompanied with cashier order(s)/cheque(s) (provided that at least one (1) cashier order shall be submitted among all the Registration(s) of Intent submitted by the registrant) each in the sum of HK\$50,000 and made payable to “**Johnson Stokes & Master**”. The number of cashier order(s)/cheques(s) shall be equal to the total number of specified residential property(ies) which the registrant intends to purchase as indicated in the relevant Registration of Intent. The Vendor reserves its absolute discretion to accept or reject any cheque;
  - (c) a copy of the registrant’s H.K.I.D. Card(s)/Passport(s) or (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary and a copy of H.K.I.D. Card(s)/Passport(s) of the director(s)

to the ICC Venue after the relevant price list(s) of the specified residential properties are made available till 8 January 2026 (both dates inclusive) during office hours (from 12:00 noon to 7:00 p.m. on 1 January 2026; from 2:00 p.m. to 7:00 p.m. on 2 January 2026; from 12:00 noon to 7:00 p.m. from 3 January 2026 to 4 January 2026; from 2:00 p.m. to 7:00 p.m. on 5 January 2026 to 7 January 2026; from 12:00 noon to 4:00 p.m. on 8 January 2026). The closing time for submission of Registration of Intent will be 4:00 p.m. on 8 January 2026. Late submission or submission outside the office hours will not be accepted. Upon completion of the procedures stated in this paragraph, the registrant will be given a receipt of Registration of Intent.

Section (III) – Pre-registration for Super Session A, Part 1a of Session A, Part 1b of Session A, Part 2a of Session A, Part 2b of Session A and Part 3 of Session A before the First Day of Sale

4. Pre-registration for Super Session A before the First Day of Sale

- (a) A registrant interested in participating in Super Session A (if the registrant is a corporation, then **all of its directors**) must bring along his/her/their original H.K.I.D. Card(s)/Passport(s), (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary, the original receipt of Registration of Intent and **personally** (or (subject to the approval of the Vendor in its absolute discretion on a case by case basis) by his/her/their/its agent) attend the ICC Venue on 9 January 2026 during office hours (from 10:00 a.m. to 10:10 a.m.) to register to participate in Super Session A. The closing time for registration to participate in Super Session A will be 10:10 a.m. on 9 January 2026. Late registration or registration outside the office hours will not be accepted. Upon completion of the procedures stated in this paragraph, the original receipt of Registration of Intent of the registrant will be chopped with a chop (the “**Session S Chop**”), to signify the completion of pre-registration of Super Session A by the registrant.
- (b) Only registrants who have pre-registered to participate in Super Session A in accordance with paragraph 4(a) and who have obtained a Session S Chop on his/her/their/its original receipt of Registration of Intent will be included in the balloting for Super Session A in accordance with Section (IV).
- (c) A registrant may pre-register to participate in either (I) any one or two Parts or all Parts of Super Session A, Part 1a of Session A and Part 1b of Session A, or (II) any one or two Parts or all Parts of Part 2a of Session A, Part 2b of Session A and Part 3 of Session A.

Card(s)/Passport(s), (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary, the original receipt of Registration of Intent and **personally** (or (subject to the approval of the Vendor in its absolute discretion on a case by case basis) by his/her/their/its agent) attend the ICC Venue on 9 January 2026 during office hours (from 10:25 a.m. to 10:40 a.m.) to register to participate in Part 1a and/or Part 1b of Session A. The closing time for registration to participate in Part 1a and/or Part 1b of Session A will be 10:40 a.m. on 9 January 2026. Late registration or registration outside the office hours will not be accepted. Upon completion of the procedures stated in this paragraph, the original receipt of Registration of Intent of the registrant will be chopped with a chop (the “**Session A1a Chop**” and/or “**Session A1b Chop**”), to signify the completion of pre-registration of Part 1a and/or Part 1b of Session A by the registrant.

- (b) Only registrants who have pre-registered to participate in Part 1a and/or Part 1b of Session A (as the case may be) in accordance with paragraph 5(a) and who have obtained a Session A1a Chop and/or Session A1b Chop (as the case may be) on his/her/their/its original receipt of Registration of Intent will be included in the balloting for Part 1a and/or Part 1b of Session A (as the case may be) in accordance with Section (IV).
- (c) A registrant may pre-register to participate in either (I) any one or two Parts or all Parts of Super Session A, Part 1a of Session A and Part 1b of Session A, or (II) any one or two Parts or all Parts of Part 2a of Session A, Part 2b of Session A and Part 3 of Session A.

Such decision will be announced and/or posted up at the ICC Venue and at the ICC Lobby and on the Designated Website after 7:00 p.m. on 9 January 2026. Registrants will not be separately notified.
  - (d) For Part 2a of Session A, the first round balloting will be carried out to divide the registrants into one or more group(s) and for the purposes of maintaining order at ICC Venue, the second round balloting to determine each registrant's "ballot result sequence" may either take place in batches at ICC Venue on the First Day of Sale or on 9 January 2026 at or after 5:15 p.m., to be decided in the Vendor's absolute discretion. Such decision will be announced and/or posted up at the ICC Venue and at the ICC Lobby and on the Designated Website after 7:00 p.m. on 9 January 2026. Registrants will not be separately notified.
  - (e) For Part 2b of Session A, the first round balloting will be carried out to divide the registrants into one or more group(s) and for the purposes of maintaining order at ICC Venue, the second round balloting to determine each registrant's "ballot result sequence" may either take place in batches at ICC Venue on the First Day of Sale or on 9 January 2026 at or after 5:20 p.m., to be decided in the Vendor's absolute discretion. Such decision will be announced and/or posted up at the ICC Venue and at the ICC Lobby and on the Designated Website after 7:00 p.m. on 9 January 2026. Registrants will not be separately notified.
  - (f) For Part 3 of Session A, the first round balloting will be carried out to divide the registrants into one or more group(s) and for the purposes of maintaining order at ICC Venue, the second round balloting to determine each registrant's "ballot result sequence" may either take place in batches at ICC Venue on the First Day of Sale or on 9 January 2026 at or after 5:25 p.m., to be decided in the Vendor's absolute discretion. Such decision will be announced and/or posted up at the ICC Venue and at the ICC Lobby and on the Designated Website after 7:00 p.m. on 9 January 2026. Registrants will not be separately notified.
  - (g) For Session B, the first round balloting will be carried out to divided the registrants into one or more group(s) and for the purposes of maintaining order at ICC Venue, the second round balloting to determine each registrant's "ballot result sequence" may either take place in batches at ICC Venue on the First Day of Sale or on 9 January 2026 at or after 4:00 p.m., to be decided in the Vendor's absolute discretion. Such decision will be announced and/or posted up at the ICC Venue and at the ICC Lobby and on the Designated Website after 7:00 p.m. on 9 January 2026. Registrants will not be separately notified.
10. The Vendor reserves the right at any time, for the purposes of maintaining order at the ICC Venue and/or facilitating smooth balloting and/or due to the reasons set out in paragraph 37 below, to adjust the date, time and location of the balloting. Any changes to the date, time and location of the balloting will be posted at the ICC Venue and at the ICC Lobby. Registrants will not be notified separately of such changes.
11. Before the first round balloting and second round balloting for each part of Session A (save and except Super Session A) and Session B takes place, the registrants shall be further divided into two sub-groups: the first sub-group consists of registrants comprising individual(s) only; and the second sub-group consists of the remaining registrants. **Registrants in the first sub-group will have priority over the registrants in the second sub-group in the selection of the specified residential properties** in each of Part 1a of Session A, Part 1b of Session A, Part 2a of Session A, Part 2b of Session A, Part 3 of Session A and Session B respectively. Card(s)/Passport(s), (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary, the original receipt of Registration of Intent and **personally** attend the ICC Venue according to the “check-in timeslot” announced and/or posted by the Vendor pursuant to paragraph 13 above. Registrant who arrives at the ICC Venue or (if directed by the Vendor) the Additional Venues (as defined below) beyond his/her/its/their “check-in timeslot” shall not be eligible for participating in Super Session A.
  - (b) On the First Day of Sale, a registrant (if the registrant is a corporation, then **all of its directors**) who pre-registered for Part 1a and/or Part 1b of Session A (as the case may be) and obtained a Session A1a Chop and/or a Session A1b Chop (as the case may be) on the original receipt of Registration of Intent must bring along his/her/their original H.K.I.D. Card(s)/Passport(s), (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary, the original receipt of Registration of Intent and **personally** attend the ICC Venue according to the “check-in timeslot” announced and/or posted by the Vendor pursuant to paragraph 13 above. Registrant who arrives at the ICC Venue or (if directed by the Vendor) the Additional Venues (as defined below) beyond his/her/its/their “check-in timeslot” shall not be eligible for participating in Part 1a and/or Part 1b of Session A (as the case may be).
  - (c) On the First Day of Sale, a registrant (if the registrant is a corporation, then **all of its directors**) who pre-registered for Part 2a and/or Part 2b of Session A (as the case may be) and obtained a Session A2a Chop and/or a Session A2b Chop (as the case may be) on the original receipt of Registration of Intent must bring along his/her/their original H.K.I.D. Card(s)/Passport(s), (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary, the original receipt of Registration of Intent and **personally** attend the ICC Venue according to the “check-in timeslot” announced and/or posted by the Vendor pursuant to paragraph 13 above. Registrant who arrives at the ICC Venue or (if directed by the Vendor) the Additional Venues (as defined below) beyond his/her/its/their “check-in timeslot” shall not be eligible for participating in Part 2a and/or Part 2b of Session A (as the case may be).
  - (d) On the First Day of Sale, a registrant (if the registrant is a corporation, then **all of its directors**) who pre-registered for Part 3 of Session A and obtained a Session A3 Chop on the original receipt of Registration of Intent must bring along his/her/their original H.K.I.D. Card(s)/Passport(s), (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary, the original receipt of Registration of Intent and **personally** attend the ICC Venue according to the “check-in timeslot” announced and/or posted by the Vendor pursuant to paragraph 13 above. Registrant who arrives at the ICC Venue or (if directed by the Vendor) the Additional Venues (as defined below) beyond his/her/its/their “check-in timeslot” shall not be eligible for participating in Part 3 of Session A.

(In other case) The registrants' order of priority for selection of the specified residential properties in Super Session A will be determined by balloting in batches on spot.

(b) (If the Vendor has carried out the second round balloting for Part 1a of Session A before First Day of Sale) The registrants' order of priority for selection of the specified residential properties in Part 1a of Session A will be determined by the “ballot result sequence” announced and/or posted by the Vendor pursuant to paragraph 13 above. (In other case) The registrants' order of priority for selection of the specified residential properties in Part 1a of Session A will be determined by balloting in batches on spot.

(c) (If the Vendor has carried out the second round balloting for Part 1b of Session A before First Day of Sale) The registrants' order of priority for selection of the specified residential properties in Part 1b of Session A will be determined by the “ballot result sequence” announced and/or posted by the Vendor pursuant to paragraph 13 above. (In other case) The registrants' order of priority for selection of the specified residential properties in Part 1b of Session A will be determined by balloting in batches on spot.

(d) (If the Vendor has carried out the second round balloting for Part 2a of Session A before First Day of Sale) The registrants' order of priority for selection of the specified residential properties in Part 2a of Session A will be determined by the “ballot result sequence” announced and/or posted by the Vendor pursuant to paragraph 13 above. (In other case) The registrants' order of priority for selection of the specified residential properties in Part 2a of Session A will be determined by balloting in batches on spot.

(e) (If the Vendor has carried out the second round balloting for Part 2b of Session A before First Day of Sale) The registrants' order of priority for selection of the specified residential properties in Part 2b of Session A will be determined by the “ballot result sequence” announced and/or posted by the Vendor pursuant to paragraph 13 above. (In other case) The registrants' order of priority for selection of the specified residential properties in Part 2b of Session A will be determined by balloting in batches on spot.

(f) (If the Vendor has carried out the second round balloting for Part 3 of Session A before First Day of Sale) The registrants' order of priority for selection of the specified residential properties in Part 3 of Session A will be determined by the “ballot result sequence” announced and/or posted by the Vendor pursuant to paragraph 13 above. (In other case) The registrants' order of priority for selection of the specified residential properties in Part 3 of Session A will be determined by balloting in batches on spot.

18. Registrants (if the registrant is a corporation, then **all of its directors**) shall **personally** select the specified residential properties which are still available at the time of selection in the order of priority determined pursuant to paragraph 17 above and in an orderly manner and within reasonable time.

19. The registrants shall **in compliance with the rules set out in the Abstract in Section (I) applicable to that Part of Session A** select and purchase specified residential properties, and purchase all the specified residential properties selected by him/her/them/it, otherwise his/her/their/its order of priority shall lapse automatically and he/she/they/it will no longer be eligible to participate in that Part of Session A.

20. For each specified residential property purchased by the registrant, the registrant shall (in addition to the cashier order(s)/cheque(s) submitted with the Registration(s) of Intent) submit on spot to the Vendor **sufficient additional**

**cashier order(s)** made payable to “**Johnson Stokes & Master**” in the following aggregate amount for payment of part of preliminary deposit of each specified residential property purchased by the registrant:-

- (a) Super Session A
  - (i) HK\$250,000 for each three bedroom unit; and
  - (ii) HK\$150,000 for each two bedroom unit; and
  - (iii) HK\$100,000 for each one bedroom unit.
  
- (b) Part 1a or Part 1b of Session A
  - (i) HK\$250,000 for each three bedroom unit; and
  - (ii) HK\$150,000 for each two bedroom unit; and
  - (iii) HK\$100,000 for each one bedroom unit.
  
- (c) Part 2a or Part 2b of Session A
  - (i) HK\$250,000 for each three bedroom unit; and
  - (ii) HK\$150,000 for each two bedroom unit; and
  - (iii) HK\$100,000 for each one bedroom unit.
  
- (d) Part 3 of Session A
  - (i) HK\$250,000 for each three bedroom unit; and
  - (ii) HK\$150,000 for each two bedroom unit; and
  - (iii) HK\$100,000 for each one bedroom unit.

21. If the number of specified residential properties the registrant purchases in Super Session A or Part 1a of Session A or Part 1b of Session A or Part 2a of Session A or Part 2b of Session A or Part 3 of Session A exceeds the number of cashier order(s)/cheque(s) submitted with the Registration of Intent being drawn, the registrant shall submit on spot to the Vendor **sufficient cashier order(s)** in the sum of HK\$300,000 for each extra three bedroom unit and HK\$200,000 for each extra two bedroom unit and HK\$150,000 for each extra one bedroom unit made payable to “**Johnson Stokes & Master**” for payment of part of preliminary deposit of each extra specified residential property as stated above. Cheque(s) shall be accepted subject to the approval of the Vendor in its absolute discretion on a case by case basis.

In case of any dispute, the decision of the Vendor shall be final and conclusive.

- (d) (in the case of Part 2a of Session A) Part 2a of Session A will end and the remaining Session A2 Units will be offered for sale in Part 2b of Session A and
- (e) (in the case of Part 2b of Session A) Part 2b of Session A will end and the Session A3 Units will be offered for sale in Part 3 of Session A.

(f) (in the case of Part 3 of Session A) Part 3 of Session A will end and the remaining Session A3 Units will be offered for sale in Session B.

23. A registrant who leaves the ICC Venue and/or (if applicable) the Additional Venues while his/her/their/its group is in session for selecting and purchasing specified residential properties shall be disqualified for participating in the selection and purchase of specified residential properties in that Part of Session A and his/her/their/its order of priority in that Part of Session A shall lapse immediately.

24. If a registrant has successfully selected the specified residential property(ies) in compliance with the rules set out in the Abstract in Section (I), the registrant shall **personally** enter into one or more preliminary agreement(s) for sale and purchase of the selected specified residential property(ies). If the registrant does not enter into all preliminary agreement(s) for sale and purchase of all the selected specified residential properties, he/she/they/it would be deemed to have given up those specified residential properties and his/her/their/its order of priority shall lapse automatically and he/she/they/it will no longer be eligible to participate in that Part of Session A.

(a) Before entering into the preliminary agreement(s) for sale and purchase in respect of the selected specified residential properties, a registrant may request the Vendor on spot to add his/her **close relative(s)** (as defined in paragraph 33(a) below) as joint purchasers and/or delete the registrant's name from the preliminary agreement(s) for sale and purchase in accordance with the requirements specified under paragraph 33 below.

26. (If the Vendor has carried out the second round balloting for Session B before First Day of Sale) The registrants' order of priority for selection of the specified residential properties in Session B will be determined by the "ballot result sequence" announced and/or posted by the Vendor pursuant to paragraph 13 above. (In other case) The registrants' order of priority for selection of the specified residential properties in Session B will be determined by balloting in batches on spot.

27. (a) On the First Day of Sale, the registrants (if the registrant is a corporation, then **all of its directors**) must bring along his/her/their original H.K.I.D. Card(s)/Passport(s) (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary, and the original receipt of Registration of Intent and **personally** attend the ICC Venue according to "check-in timeslot" announced and/or posted by the Vendor pursuant to paragraph 13 above. Registrants who arrive at the ICC Venue or (if directed by the Vendor) the Additional Venues beyond their "check-in timeslot" shall not be eligible to participate in Session B.

(b) In case the ICC Venue shall become insufficient to accommodate all the registrants, the Vendor may for safety reason, make use of the Additional Venues to accommodate some of the registrants by making announcement and/or posting notice(s) at the ICC Venue and the Additional Venues.

28.
